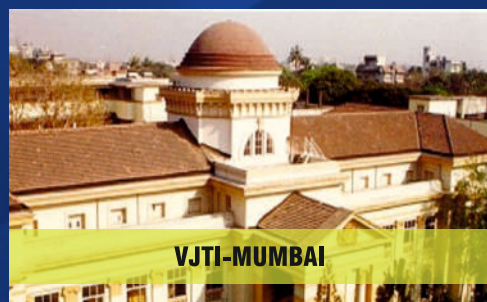

Details of Fee & GST Rule

- Refund Application in the prescribed format will be accepted along with Original Fee Receipt & Spectrum Identity Card.
- Refund will be credited in Father / Mother / Student Bank Account through NEFT / RTGS mode only. For this you have to submit
- Cancelled Cheque along with Refund Application.
- Scholarship can be availed as per the fee structure/scholarship detail plan only.
- The registration fee of Rs. 300 is non refundable. Payment of Registration Fee does not Guarantee Admission.
- The student/parent should understand that fee refund is a part of institute's policy and we strictly follow the refund rules & regulations as mentioned above.
